## Transportation Alternative funds available

The Transportation Alternatives Program (TAP) is authorized under the Moving Ahead for Progress in the 21<sup>st</sup> Century Act (MAP-21) to provide for a variety of alternative transportation projects, including many that were previously eligible activities under separately funded programs. The TAP replaces the funding from pre-MAP-21 programs including Transportation Enhancements, Recreational Trails, Safe Routes to School, and Scenic Byways, wrapping them into a single funding source.

The mission of the Transportation Alternatives Program is to improve our Nation's communities through leadership, innovation, and program delivery. The funds are available to develop a variety of project types located in both rural and urban communities to create safe, accessible, attractive, and environmental-

ly-sensitive communities where people want to live, work, and recreate.

The Transportation Alternatives Program consists of: Transportation Alternative Definitions, Recreational Trails Program (RTP), Safe Routes to School (SRTS) activities, and Boulevards from Divided Highways.

There are 13 possible transportation alternatives activity categories, which have been grouped into three groups by common characteristics. Although the federal government provides guidance and ensures compliance, states are responsible for selecting their own alternatives projects.

## Amendment to FY'13 CDBG Action Plan

Currently, the Department of Economic Development has established the following funding categories for its FY'13 CDBG allocation:

- Water/wastewater
- Economic Development
- Community Facilities
- Emergency
- Demolition

An adjustment of more than 25% of the total annual allocation, or the creation/elimination of a category will require a sub-

stantial amendment of this plan.

The Department proposes to amend the 2013 CDBG Action Plan to allow for the creation of a funding category for general public infrastructure (not including water and wastewater as a funding category for those activities already exists). This category will be used should FY'13 funds become available. The Department retains the ability to transfer up to 25% of the total annual allocation between funding categories as needed.

## Atchison County Hazard Mitigation planning meetings

The Regional Council is partnering with the Atchison County Commission to update and improve the existing Multi-jurisdictional Hazard Mitigation Plan as required by the Federal Emergency Management Agency (FEMA). Hazard Mitigation is defined as any sustained action taken to reduce or eliminate the long-term risk to life and property from hazardous events. It is an on-going process that occurs before, during, and after disasters and serves to break the cycle of damage and repair in hazardous areas.

Public meetings are held to help improve

the accuracy and current content of the plan, as well as to collect public input. The Northwest Missouri Regional Council of Governments invites all interested citizens to participate in public meetings to update the plan.

## Regional Council to assist with strategic planning in Grant City

The City of Grant City hired the Regional Council to facilitate a community-wide strategic planning process in 2008. The final work product was a 5-year strategic plan that the City has used to coordinate multiple community-based projects, including

updates to their swimming pool, park, downtown and many other projects. The City's current plan expired in 2013 and the City Council has now hired the Regional Council to once again assist them with the development of a new 5-year strategic plan.

The planning process will include a series of public meetings during which local residents will have the opportunity to give input for the final draft of the new plan. It is anticipated that the final plan will be complete by December 2014.

## Council to host resiliency workshops for small businesses

The Regional Council invites small business owners in Holt and Atchison counties to attend a series of Business Resiliency Workshops. In the wake of the 2011 flooding, levees breached along the Missouri River wreaked havoc on the surrounding floodplain communities. In 2014, recovery is still taking place in communities within these two counties. The Regional Council is currently working on a Disaster and Economic Recovery and Resiliency Strategy to prevent future damage and job loss. ## Staff represents MORA at Missouri State Fair in August

Northwest Missouri recycling activities were represented at the Missouri State Fair this year by participation in the Missouri Recycling Association booth. Community and Environmental Planner, Linda Laderoute, worked at the fair booth talking to visitors about the recycling activities in our Solid Waste Management District. With a bucket of pellets from Northwest's Pellet Plant, it was easy to start up conversations

about our local recycling accomplishments. The Missouri Recycling Association Annual Conference was held in Springfield, MO the second week in September. There was good representation from our region including representatives from NoCoMo, Northwest University, Kawasaki, and the Solid Waste Management District. The conference had many good sessions addressing different aspects of recycling activities.

Presentations included information about the legislative issues, household hazardous waste, composting, scrap tires, and other topics of current interest. A trade show market place was available where attendees could learn about projects and state of the art equipment available for the recycling industry.

## NW Missouri Recycles Survey: project update

The NW Missouri Recycles Survey project sponsored by a grant from the USDA Rural Utilities Solid Waste Management Program provided technical assistance for the development of recycling plans for the cities of Grant City, Hopkins and Skidmore. The Hopkins Plan has been adopted and Grant City and Skidmore plans are in the final draft stage.

The USDA grant began in October of 2013. The *NW Missouri Recycles Survey* was available from December through March to gather information about recycling activities and attitudes in our five-county region. In May, reports were sent out to all the endorsing communities and a meeting was held for those communities ready to prepare a recycling plan. The Recycling Plan Tool Kit was handed out at the meeting and technical assistance provided to the cities
